# Carbon Footprint Verification for The ID Register Limited

Dear Dan,

I am delighted to present the results of your successful carbon footprint verification. Carbon Footprint Ltd has reviewed the methodology used; the sources of your energy and business travel data; and the calculation for The ID Register.

The ID Register is a centralised investor onboarding utility for fund managers, operating from its single office on the Island of Guernsey. Most of the work is computer based but occasionally air travel is required to visit clients in mainland UK. The ID register has experienced rapid business growth over the 2020 assessment period, despite the restrictions imposed by the Covid-19 pandemic. In light of this, employees will evaluate how effectively they have operated over the last year, with a view towards much reduced business travel to mainland UK going forwards. Guernsey has been significantly less affected by the disruption caused by Covid 19 and experienced only a small period of lockdown between the end of March and early June.

### How was the carbon footprint calculated?

The ID Register has used the online carbon calculator on www.carbonfootprint.com to calculate its carbon footprint, for the period 1<sup>st</sup> January 2020 to 31<sup>st</sup> December 2020. The calculation uses the 2020 metrics developed by the Department for Business, Energy & Industrial Strategy (BEIS) for the calculation of the business travel emissions. For the office electricity emissions, a Guernsey specific grid factor<sup>1</sup> has been used.

The carbon footprint assessment includes:

- Building electricity consumption
- Flights
- Taxi travel

## **Data Sources and Accuracy**

Carbon Footprint Ltd has discussed the data sources with The ID Register (see table below).

#### **Results**

Your total carbon footprint for the period 1<sup>st</sup> January 2020 to 31<sup>st</sup> December 2020 is 4.78 tonnes of CO<sub>2</sub>e. A breakdown of the results is shown in the table below.

## **Conclusions**

The ID Register has successfully calculated its carbon footprint of 4.78 tonnes  $CO_2e$  for the period  $1^{st}$  January 2020 to  $31^{st}$  December 2020. I have therefore provided The ID Register with a 12-month license to use the 'Carbon Footprint –  $CO_2e$  Assessed Organisation' logo, for use in all external communications.
